Some of the elements included in our extensive transformation program include healthy meals, counseling, drug/alcohol recovery support, mental health therapy, social skills development, job training, career coaching, medical health support, children's services, and transportation. Our hope is to assist our clientèle with reintegration into society, from dependency mode, to becoming productive citizens. THCC offered 262 hours of Adult Continuing Education, 1,386 hours of job assistance and the use of a technology lab, 54,700 hot meals provided through Isabella's Kitchen, and 152 individuals dedicated their lives to Christ. There were 62 program participants with an 83% program graduation rate.
